The meeting was called to order by Mayor Swintkowski at 6:00 p.m.

#### Presentation of Plaques to Council President Speros & Mayor Swintkowski

Chief Clapero, on behalf of the council and employees, presented Mayor Swintkowski with a plaque and thanked him for his 30 years of service to the City of Hayward. Director McCue, on behalf of the council and employees, then presented Ald. Speros with a plaque and thanked him for his 21 years of service to the City of Hayward.

Dave Moeller – Requests for Street of Dreams Car Show to be held on Saturday, June 17, 2017 Dave Moeller and Doug Lein addressed the mayor and council members regarding the idea of a car show event to be held on Main Street on Saturday, June 17<sup>th</sup> (the weekend before Musky Festival). Mr. Moeller and Mr. Lein requested that Main Street be closed on Saturday, June 17<sup>th</sup>, in order for the car entries to be parked on Main Street. Also requested was permission for public consumption of alcohol so that the attendees could enjoy an alcoholic beverage while viewing the car entries. Concerns were raised regarding the closing of Main Street for two Saturdays in a row; and allowing people to walk up and down Main Street with alcohol. The mayor and council members requested that Mr. Moeller and Mr. Lein speak with each of the business owners on Main Street regarding the car show event; and to bring back a form signed by each of the business owners as to whether they would be in favor or not in favor of closing Main Street for the event. A motion was made by Ald. Gillis, seconded by Ald. Kennell to table any decision regarding the requests for the Street of Dreams Car Show event at this time. The Street of Dreams Car Show requests will be placed on the agenda of the Annual Organizational Meeting, scheduled for April 18<sup>th</sup>, in order to allow the car show event organizers time to speak with the business owners on Main Street.
