Ordinance No. 527: Annexation Ordinance – Jeremy Hill / Hill Construction LLC

2. **From Police & Fire of 05/09:**
 - A. Table any decision regarding the purchase of the Panasonic Toughbook computers for the squad cars at this time; Chief Clapero is to check into what brand of computers have been purchased and are being used by the county; and obtain additional quotes for other brands of computers.
 - B. The \$17,335 quote submitted by General Communications for the purchase of three, complete Digital Ally in car video systems and the repair of the one Digital Ally video system currently used by the police department.

 - A. The making of the temporary ATV trail along S Florida Avenue & S First Street a permanent part of the City of Hayward's ATV trail system.
 - B. Lift Stations: the Hayward Shores and Armory lift stations must remain the responsibility of the City. Director McCue was informed that the lift stations would have had to have been made private at the time of installation.
 - C. The hiring of Andrew Metcalf to fill the planting, weeding & watering position, as well as, cleanup at the city beach.
 - D. Tom Shuman's request for the City of Hayward to provide and pay for the pumping and cleaning of the portable toilet located at Greenwood Cemetery.
