2. From Police & Fire of 05/08:

- A. Update: Three of the four squad car computers are up and running. A technician is working to get the fourth computer up and running.
- B. Update: Three of the four squad car cameras are working; Digital Alley will be sending a technician to Hayward to get the fourth camera operational.

- C. Information: Chief Clapero will be looking into the possibility of purchasing radar units with federal seizure funds. The units cost between \$3,000 and \$4,000 each.
- D. Information: A total of \$35,000 was included in the 2017 budget for the purchase of a squad car. The car will cost approximately \$25,000; \$5,000 will be needed to equip the car; and it will cost approximately \$4,800 to install the equipment and stripe the car. The total cost of the new squad car should come in just under the budgeted amount.
- E. Information: Chief Clapero will be checking into the possibility of obtaining a COPS grant to fund an additional officer position. Chief Clapero will bring his findings back to the council next month.
- F. The selling of the City's ownership interest in the UTV, trailer and water tank to the Town of Hayward. Funds received to be added to the fire department's capital projects account.

3. From Public Works of 05/08:

- A. Director McCue stated that he has been informed that a hydraulic thumb cannot be installed on the model 420D Caterpillar Backhoe Loader; therefore, he is no longer seeking permission to purchase and install the hydraulic thumb on the backhoe.
- B. The agreement provided by Ayres Associates Inc. in the amount of \$75,700 for the design and bidding phases for the replacement of water main and sanitary sewer system in conjunction with the WI DOT Hwy 27 project.
- C. Payment of the third pay request submitted by Haas Sons Inc. in the amount of \$33,555.18 for the change order adding curb and gutter along Vermont Avenue and final counts and measurement totals for the 5th Street project.
