Pledge of Allegiance

The Pledge of Allegiance was recited.

Hayward Chamber of Commerce – Request for financial assistance with crossing guards for Musky Festival

Chris Ruckdaschel, Hayward Chamber of Commerce, requested that the City pay the fees associated with the crossing guards at Main Street and Hwy 63 during the Musky Festival event. Chief Clapero estimates the fees associated with the crossing guards to be \$1,400 to \$1,500 for the Musky Festival event. No official action was taken. The Hayward Chamber of Commerce's request for financial assistance with the crossing guard fees for Musky Festival was referred to the Police Committee for further discussion.

Depending on the weather, fine grading is scheduled for Wednesday and Thursday; paving is scheduled for Friday and Monday; and painting will be completed shortly thereafter.
- F. Director McCue stated that the Town of Hayward is planning on paving Johnson Street this year. The City would receive a better rate if the City's portion is paved at the same time the Town's portion is paved. Director McCue also stated that Olker Road needs to be repaired as the road is washing into the creek. Director McCue will obtain a quote to pave certain city streets from Monarch Paving Company and report back next month.

Be it hereby resolved that the City of Hayward informs the Department of Natural Resources that the following actions have been set forth by the Common Council of the City of Hayward:

- 1. Review of the 2017 Compliance Maintenance Annual Report (CMAR).
- 2. Address the groundwater quality issue:
 - A. The City has revised and updated its Land Management Plan to include the effluent distribution of the spray irrigation site and nitrogen removal in seepage cell #4; the expectation is that this will reduce the total nitrogen in the ground water.
 - B. The City of Hayward will also continue to pursue alternative nitrogen reduction treatment options.
 - C. Groundwater samples will continue to be taken from various monitoring wells and analyzed on a quarterly basis.

- A. The purchase of two pedestrian crossing signs for an approximate cost of \$275 per sign; funds to purchase the signs to come from room tax revenues.
