Lynn Fitch, Sawyer County / Lac Courte Oreilles Economic Development Corporation – Update regarding planning and projects

Lynn Fitch, Sawyer County / LCO Economic Development Corporation, provided the mayor and council members with an update regarding current and future projects and plans, as well as, the creation of a Business Improvement District.

American Birkebeiner / Lumberjack World Championships – Request for Temporary **Camping**

A motion was made by Ald. Miller, seconded by Ald. Gillis to approve the request for temporary camping, presented by Kristy Maki on behalf of the American Birkebeiner / Lumberjack World Championships, on the vacant Lumberjack World Championship's property located off Hwy B, for a period of ten days; starting five days prior to the event. Hill Construction LLC – Request for the special assessment of water & sewer installation and street construction costs for the development of the property located between Guard Street and Hospital Road; and request for Tax Increment Financing Dollars
