ORDINANCE NO. 545**

**AN ORDINANCE REGULATING  
TIME FOR PLACEMENT OF REFUSE/TRASH/RECYCLABLE CONTAINERS**

**WHEREAS**, the City of Hayward is under contract with Eagle Waste & Recycling, Inc. to collect refuse/garbage/recyclables from the residents of the City of Hayward; and

**WHEREAS**, Eagle Waste & Recycling, Inc. has designated the collection times within the City of Hayward; and

**WHEREAS**, the City of Hayward deems it necessary to establish further rules regarding collection of residential and commercial waste in order to enhance and improve the environment and promote the health, safety, and welfare of the City of Hayward.

**NOW, THEREFORE**, the Common Council of the City of Hayward, Wisconsin, does ordain as follows:

**SECTION I. REFUSE/TRASH/RECYCLABLE CONTAINERS.**

Receptacles and containers for refuse that are placed on the curb of a public street or a public alley for collection as designated by the collector, shall be placed behind the curb of the public street or on the edge of the public alley, not earlier than twenty-four (24) hours before the regular collection time and shall be removed from the curbside or alley collection point within twenty-four (24) hours after the regular collection time.

**SECTION II. CITATIONS AND FORFEITURES.**

- A. Issuance of citations under Sec. 66.119, Wis. Stats., is hereby authorized.
- B. The Clerk of Court, Sawyer County, Wisconsin, shall have the authority to accept cash or deposits for the forfeitures, and /or bond pursuant to the schedule set forth below, or as ordered by the Circuit Court for Sawyer County:
1. First Alleged Offense. Fifty Dollars (\$50.00) plus court costs and court assessments.
  2. Second Alleged Offense (Within One Year). One hundred Dollars (\$100.00) plus court costs and court assessments.
  3. Third Alleged Offense and Subsequent Alleged Offenses (Within One Year). Two Hundred Dollars (\$200.00) plus court costs and court assessments.
- C. Any and all changes in the forfeiture and/or bond for this Ordinance shall be set by Resolution, adopted by the majority vote of the Common Council of the City of Hayward.


**SECTION III. EFFECTIVE DATE.**

This ordinance shall become effective upon its passage and publication, as provided by law.
