Public Notice is hereby given that the City of Hayward Planning Commission will conduct a Public Hearing on Thursday, August 8, 2024, at 5:30 P.M. in the Council Chambers at City Hall, 15889 W Third Street, to act upon the following:

1) Matthew Lein, OCR 1, LLC – applicant & owner of 10709 Minnie Avenue: Lot one (1), Block One (1), Fuley’s addition to the City of Hayward, excepting the North 75 feet thereof, Sawyer County, Wisconsin. Parcel Identification No.: 236-120-01-0101. A change in zone district from Residential-One (R-1) to Commercial-One (C-1) with a Conditional Use Permit for storage buildings is being requested.
