Amanda Johnson, Outdoor Ventures – Shamrock Shuffle Event Requests

A motion was made by Ald. Miller, seconded by Ald. Kennell to approve the requests (same as in previous years), as presented by Amada Johnson, for the Shamrock Shuffle event to be held on Saturday, March 16, 2019. Motion carried.

A motion was made by Ald. Miller, seconded by Ald. Kreyer to approve the request to stage the start of the 37th Annual Lion's Pre-Birkie Cross Country Ski Race at the City of Hayward beach, as submitted in a letter dated December 12, 2018, by Stephanie Poplin on behalf of the Hayward Lions Club. Police Chief & Assistant Police Chief Wages for 2019: Police Chief forgoing his three percent wage increase for 2019; the Assistant Police Chief receiving a three percent wage increase on January 1, 2019 and a three percent wage increase on July 1, 2019

A motion was made by Ald. Gillis, seconded by Ald. Kreyer to table any decision regarding the police chief forgoing his three percent wage increase for 2019; and the assistant police chief receiving a three percent wage increase on January 1, 2019 and an additional three percent wage increase on January 1, 2019 until an opinion regarding the request can be obtained from the City's labor attorney. Sawyer County Zoning & Conservation: Bob Thompson & Sons – The carry forward of conditional use permit #01-010 for the location of a non-metallic mineral extraction operation, including rock crusher and hot mix plant

A motion was made by Ald. Kennell, seconded by Ald. Swan to direct Clerk Poppe to complete the Sawyer County Zoning and Conservation Administration form regarding the carrying forward of Bob Thompson & Sons' conditional use permit #01-010 for the location of a non-metallic mineral extraction operation – stating that the City has no objections to Conditional Use Application #19-004. Motion carried.

- Director McCue informed the mayor and council members that A-1 Excavating was D. the low bidder on the Hwy 27 DOT project; the bid amount for the water & sewer portion of the project, for which the City of Hayward will be responsible, is \$1,067,045.63.
