**Peter Spencer, Chequamegon Mountain Bike Festival – Request to stage the start of the Chequamegon 40 and Pro Start events on Main Street on Saturday, September 18, 2021**

A motion was made by Ald. Miller, seconded by Ald. Gillis to approve the requests, as submitted by Peter Spencer in an email dated February 15, 2021, to stage the start of the Chequamegon 40 and Pro Start events on Main Street on Saturday, September 18, 2021. Motion carried.

**Kristy Maki, American Birkebeiner Ski Foundation – Birkie 2022 Plans and an update on the 2021 Lumberjack World Championships**
