Approve allowing the Terry Peterson Foundation to apply for an Enbridge grant and other grants, to help offset the improvements at Shue's Pond, under the city's name when the grants become available instead of waiting to get approval at a meeting; and to approve the city setting up a fund for the Shue's Pond City Park beautification improvements.
