The meeting was called to order by Mayor Munich at 6:00 p.m.

Hayward Civic Club – Request to display fireworks on July 4, 2022 and to display a banner across Main Street from June 27th through July 5th

A motion was made by Ald. Kennell, seconded by Ald. Williamson to approve the Hayward Civic Club’s request to display fireworks on July 4, 2022 – pending the receipt of certificates of insurance from the Hayward Civic Club and Spielbauer Fireworks Co Inc.; and to approve the Hayward Civic Club’s request to display a banner across Main Street from June 27 - July 5, 2022. Motion carried.

Kristy Maki, Lumberjack World Championships – Update & requests for the 2022 events to be held July 28-30

A motion was made by Ald. Miller, seconded by Ald. Gillis to approve the requests, as presented by Kristy Maki on behalf of the Lumberjack World Championships, for the 2022 events to include: allowing handicap parking on the pedestrian / bike path along Hall of Fame Drive during the 2022 events; allowing a banner to be displayed across Main Street from July 5 - August 3, 2022; allowing the use of City owned property between Hall of Fame Drive and Pine Tree Drive for volunteer parking; and to have the police department provide additional security throughout the various events and traffic control for the Lumberjack 5K Run. Motion carried.
