#### Clerk's Report

The Wastewater Treatment Plant Equipment Replacement CD 2959 in the amount of \$564,139.22 matured on April 23<sup>rd</sup>, interest earned in the amount of \$12,426.61 and the 2025 allocation of \$32,000 were added; the CD was renewed for an amount of \$608,565.83 for a term of 9 months at 4.10 percent.

CD 5407 in the amount of \$106,401.82 matured on April 23<sup>rd</sup>, interest earned in the amount of \$2,276.07 was added; the CD was renewed for an amount of \$108,677.89 for a term of 9 months at 4.10 percent.

\$500,000 was transferred from the water & sewer premier account to a 9-month CD at a rate of 4.10 percent; another \$500,000 was transferred from the water & sewer premier account to a 9-month CD at a rate of 4.10 percent.
