RESOLUTION NO. 23-09

A RESOLUTION DECLARING OFFICIAL INTENT

TO REIMBURSE EXPENDITURES FROM PROCEEDS OF BORROWING

WHEREAS, the City of Hayward, Sawyer County, Wisconsin (the "Municipality") plans to undertake the Reconstruction of 2nd Street (the "Project"); and

WHEREAS, the Municipality expects to finance the Project on a long-term basis by obtaining a promissory note (the "note"); and

WHEREAS, because the note will not be issued prior to the incurring of project costs, the Municipality must provide interim financing to cover costs of the Project incurred prior to receipt of the proceeds of the note; and WHEREAS, it is necessary, desirable, and in the best interests of the Municipality to advance moneys from its funds on hand on an interim basis to pay the costs of the Project until the note proceeds are issued.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Hayward that:

Section 1. <u>Expenditure of Funds</u>. The Municipality shall make expenditures as

needed from its funds on hand to pay the costs of the Project until note proceeds

become available.

Section 2. <u>Declaration of Official Intent</u>. The Municipality hereby officially declares

its intent under Treas. Regs. Section 1.150-2 to reimburse said expenditures with proceeds of the note, the principal amount of which is not expected to exceed

\$500,000.

Section 3. <u>Unavailability of Long-Term Funds</u>. No funds for payment of the Project from

sources other than the note are, or are reasonably expected to be, reserved, allocated on a long term basis, or otherwise set aside by the Municipality

pursuant to its budget or financial policies.

Section 4. <u>Public Availability of Official Intent Resolution</u>. This Resolution shall be

available for public inspection at the City of Hayward Clerk's office within 30 days after its approval in compliance with applicable State law governing the

availability of records of official acts including Subchapter II of Chapter 19, and

shall remain available for public inspection until the note is issued.

Section 5. <u>Effective Date</u>. This Resolution shall become effective upon approval and

adoption.

FINAL RESOLUTION AUTHORIZING THE INSTALLATION OF BLACKTOP PAVEMENT; AND PROVIDING FOR ASSESSMENT OF COSTS UNDER SECTION 66.0703, WISCONSIN STATUTES

WHEREAS, the owners of the following described property requested that the City of Hayward provide for the installation of blacktop pavement, and all owners signed and filed a petition with the governing body of the City of Hayward, Wisconsin, for waiver of all special assessment hearings and notices pursuant to §66.0703(7)(b). The City of Hayward provides for the assessment of such for the property described as follows: That part of the Southeast Quarter of the Southwest Quarter of Section 22, Township 41 North, Range 9 West, in the City of Hayward, Sawyer County, Wisconsin, more particularly described as Outlot 1 of Certified Survey Map No. 7114, Volume 27, Page 253, as Document No. 334112 and Outlot 4 of Certified Survey Map No. 6416, Volume 23, Page 239, as Document No. 299977.

Parcel Identification Number: 236-941-22-3418

NOW, THEREFORE, be it resolved by the Common Council of the City of Hayward as follows:

- 1. Installation of blacktop pavement, as requested by the petitioner.
- 2. The City Public Works Director shall cause the installation of the blacktop pavement.
- 3. The costs of the installation of the blacktop pavement shall be paid one hundred percent (100%) by the petitioning property owner.
- 4. Upon completion of the work authorized by this Resolution, the City Public Works Director shall file a record of the costs of the construction on, or in front of, each parcel in the Office of the City Clerk.
- 5. Assessments for all projects included in the report are hereby combined as a single assessment, but any interested property owner may object to each assessment separately, or all assessments jointly for any purposes.
- 6. When the record of the costs of construction has been filed in the City Clerk's office, the Clerk shall enter the costs of the blacktop pavement on the tax roll against the lots or parcels served; and shall notify the owners of the amount of the charges against the premises. The charges shall constitute a lien against the premises served, or to be served, until paid in full. Assessments shall bear interest at the rate of 5.75 percent per annum on the unpaid balance from August 1, 2023 until paid. Assessments may be paid in full or in ten (10) annual installments to the City Clerk. The first installment is due on August 1, 2024, and annually thereafter, until paid in full. Installments not paid when due, shall be placed on the next tax roll after the due date for collections. Installments of assessments, if not paid when due and placed on the tax roll, shall be assessed a ten percent (10%) surcharge.
- 7. The City Clerk shall publish this resolution as a class 1 notice under Ch. 985, Stats., in the assessment district and mail a copy of this resolution and a statement of the final assessment against the benefited property, together with notice of installment payment privileges to every property owner whose name appears on the assessment roll whose post office address is known, or with reasonable diligence can be ascertained.
