- B. Mowing contracts for the 2018 Season: Greenwood Cemetery – Thomas Shuman in the amount of \$14,428; Wastewater Treatment Plant – Affordable Property Maintenance in the amount of \$2,900; and Parks/Beach – Affordable Property Maintenance in the amount of \$3,100.
  - C. Awarding the bid to Don Johnson’s Cumberland Motors for the purchase of a 2018 Ram 2500 Regular Cab 4x4 in the amount of \$25,500 and a 2018 Ram 1500 Crew Cab 4x4 with Ram box in the amount of \$28,850; less a trade in allowance of \$13,500 for a 2006 Chevy with snow plow and \$11,500 for a 2008 Chevy. (Total net price of \$29,350)
  - D. Repair of the damages to the transfer switch at Well #7 in the amount of \$5,122.16 (Jim St. Catherine - \$120 & Fabrick - \$5,002.16); costs to be submitted to Municipal Property Insurance Company for reimbursement – less the \$500 deductible. Damage was caused by lightning during a storm on September 22, 2017.
  - E. The purchase of six tires for dump truck #16 from Pomp’s Tire Service Inc. for an amount not to exceed \$3,000.
