Sam Barot, Destiny Hospitality LLC – Incentives for new development that the City could possibly offer

Mayor Munich informed the council members that he met with Sam Barot, Destiny Hospitality LLC, regarding a proposed \$17 million development on a six acre parcel within the City. Mr. Barot has inquired as to the possibility of the City offering an incentive(s) to offset the development costs. Ald. Gillis stated that he would like to see plans ahead of making a decision. Mayor Munich will contact Mr. Barot and let him know he needs to present his proposal and requests to the full council. No action was taken.

2. From Police & Fire of 11/14:

A. The Hayward Community School District has approached Chief Clapero regarding the addition of a second School Resource Officer. Chief Clapero will be researching the feasibility of adding the position and any grants that might be available to offset the additional costs.

- B. Chief Clapero stated that there have been an increasing number of calls & complaints regarding the AmeriVu, from parking issues to illegal activity. Chief Clapero and Attorney Kelsey will research the possibility of enacting an ordinance or policy that would make the property owner responsible for an excessive number of calls to the same location.
- C. The Police Department has received a number of calls regarding people begging. Begging is a right protected by the First Amendment. Attorney Kelsey and Chief Clapero will be researching begging ordinances adopted by other communities. The City's ordinance addressing begging was adopted in 1938 and will also be reviewed in the process.

3. From Public Works of 11/14:

- A. The Hayward Hospital is looking to expand and has inquired as to the City extending the water main to serve the hospital. The City and Hospital will be researching the feasibility of extending the water main to the Hayward Hospital.
- B. The final payment of retainage in the amount of \$7,383.01 to Skid Steer Guy LLC for the California Avenue project.
- C. The 2023 Mowing Proposals to include: Greenwood Cemetery Thomas Shuman in the amount of \$17,828; Parks Affordable Property Maintenance in the amount of \$3,500; and the Wastewater Treatment Plant Affordable Property Maintenance in the amount of \$3,500.
- D. The purchase of a 2022 Trackless MT57 in the amount of \$186,899 from MacQueen Equipment.
- E. Waiving the requirement that all new employees earn 90% of the pay rate for the first 90 days for Keith Wehmhoefer; Mr. Wehmhoefer is to receive full pay effective immediately and will be reimbursed the hourly difference (\$2.40 per hour) from his start date.
