2026 City of Hayward Budget

Budget Hearing – 2026 City of Hayward Budget

A public hearing was held regarding the 2026 City of Hayward Budget. The overall 2026 City of Hayward budget amount (\$2,272,893) decreased \$6,120 from the 2025 budget amount (\$2,279,013). The proposed 2025 tax levy amount was listed at \$1,392,556; an increase of \$48,393 levied for taxes for 2024. The majority of the increase (\$29,978) was for debt service to make the final principal and interest payments on the loan obtained for the 5th Street Project. The remaining \$18,415 was the amount the levy could be increased according to the levy limit worksheet.
