

ORDINANCE #437 & #479

**An Ordinance codifying parking regulations within the City of Hayward**

The Common Council of the City of Hayward do ordain as follows:

1. Ordinance Nos. 38, 48, 54-A, 71, 72, 73, 74, 75, 77, 84, 87, 95, 99, 105, 117, 125, 126, 140, 142, 153, 157, 192, 207, 230, 243, 246, 252, 282 and 319 are repealed in total.
2. All Wisconsin Statutes, and amendments thereto, relating to parking are incorporated herein by reference.
3. There shall be no parking on the following streets or highways at any time:
  - A. Both sides of Railroad Street
  - B. Both sides of State Trunk Highway 63
  - C. Both sides of State Trunk Highway 77
  - D. Both sides of State Trunk Highway 27
  - E. Both sides of County Highway B
4. There shall be no parking between the hours of 2:00 a.m. and 6:00 a.m. on the following streets within the City of Hayward:
  - A. Main, between Railroad Street and West Fifth Street
  - B. Kansas Avenue, between U.S. Highway 63 and East Fifth Street
  - C. Dakota Avenue, between Highway 63 and West Fifth Street
  - D. Second Street, between Wisconsin Avenue and California Avenue
  - E. Third Street, between Wisconsin Avenue and California Avenue
  - F. Fourth Street, between Wisconsin Avenue and California Avenue
  - G. Fifth Street, between Wisconsin Avenue and California Avenue
5. Parking of motor vehicles on the streets within the City of Hayward from the first day of November of each and every year to the 15<sup>th</sup> day of April of the subsequent year shall be allowed only on the odd numbered side of the street on odd numbered days and on the even numbered side of the street on the even numbered days, between the hours of 8:00 a.m. and 5:00 p.m.
6. Paragraph 5 shall not apply to the streets and highways listed in paragraphs 3 and 4 above.
7. There shall be no parking on either side of West Third Street from Dakota Avenue westerly for one-half (1/2) block.
8. Parking shall be allowed on a 24 hour basis on the south side of East Fourth Street from the alley which connects East Third Street to East Fourth Street, easterly to Kansas Avenue. Said parking shall be limited to the owners and/or occupants of properties located at 10615 Kansas Avenue and 15855 Fourth Street.
9. Parking on all municipal lots shall be for no more than 24 hours at any one time.
10. The Common Council, the Public Works Department and/or Police Department of the City of Hayward may prohibit, limit or allow parking on City streets on a case by case basis. In the event parking is limited or prohibited on a case by case basis, temporary signs shall be placed prior to enforcement.
11. All private parking lots which are appropriately signed, designating parking hours and permitted users, may be enforced by the City of Hayward.
12. There shall be no parking on either side of any street, within 30 feet of the right of way of the intersecting streets within the City of Hayward, except for those streets which have marked parking spaces as established by the City of Hayward Public Works Department.

13. Parking at all marked and signed handicap stall/areas shall be limited to those vehicles which display the appropriate handicapped sign or sticker.
14. All vehicles shall be parked at least 15 feet from any mailbox.
15. Parking on the south side of West Third Street from Wisconsin Avenue to the alley midway between Wisconsin Avenue and Dakota Avenue shall be limited to a maximum of 2 hours between the hours of 7:30 a.m. and 4:00 p.m., Monday through Friday.
16. The forfeitures for a violation of this Ordinance are as follows:
  - a. \$25.00, plus applicable court costs and all costs of prosecution of the offense.
  - b. The forfeiture for any violation of a handicapped zone shall be \$100.00, plus applicable court costs and all costs of prosecution of the offense.
17. Any amendments to the forfeiture schedule for violation of this Ordinance may be established by a resolution adopted by a majority vote of the Common Council of the City of Hayward.
18. Invalidation of any part of this ordinance by a Court of law shall not invalidate the remaining portions thereof.
19. This ordinance shall become effective upon its passing by the Common Council of the City of Hayward and publication thereof as provided by law.
